

## Regulation regarding access for school groups to TTG Incontri, SIA Guest and SUN 2018

### INTRODUCTION

These three trade shows held together represent the production and sales chain of the tourism product as a whole. Italian Exhibition Group SpA has established a simple set of regulations that school groups must comply with.

The number of students allowed to visit the show is limited.

### ARTICLES

1. School groups from hotel and tourism schools may only visit if the institutions are accredited, if the group is in its final year of studies, and only on **12 October 2018**.
2. Accreditation may be obtained by writing to [annamaria.bonfe@iegexpo.it](mailto:annamaria.bonfe@iegexpo.it) no later than 30 September 2018.
3. Groups may only consider themselves officially invited after having received a written response accepting their application to visit the show.
4. Once the maximum limit of pre-accredited school groups is reached (based on number of students), visit requests shall be rejected.
5. SCHOOL PARTIES THAT COME TO THE SHOW WITHOUT ACCREDITATION SHALL NOT BE ADMITTED.
6. There is no entry cost, as entry is free for industry operators.
7. It is strictly prohibited at the show to:
  - 7.1. sit on the floor;
  - 7.2. throw any kind of waste on the floor;
  - 7.4. create disorder in the pavilions;
  - 7.5. disturb exhibitors or visitors in any way.
8. Anyone disobeying one or more of the rules listed above may be removed from the exhibition area, along with the school group to which they belong. In addition, the Institution of the student responsible for breaking the rules shall be banned from entry to the trade fair for the next three years.
